Manchac Wreck

One of the deadliest and largest Interstate Highway pileups in Louisiana history occurred in St. John in October of 2023, involving 168 vehicles, injuring 63 people and causing eight deaths. Marsh fires, coupled with dense fog created near zerovisibility for morning drivers on I-55 near Manchac.

"You could hear vehicles crashing on the radio of a responding deputy," Sheriff Tregre said. "We dispatched all available personnel and immediately notified local broadcast outlets to tell people to stay off I-55."

Cleanup took weeks and the identification of victims was hampered by intense vehicle fires. A speeding truck driver who caused the initial collision was indicted for negligent homicide.





Training

We stay prepared to handle any situation at any time by training every day. Many sessions are held at the 33,000 squarefoot Lloyd B. Johnson Training Center (LBJTC) on Cambridge Drive in LaPlace, with other instruction at numerous sites across the parish and state.

"Our training programs are the backbone of this department, and we continually enhance them," Sheriff Tregre said. "By learning new skills and strengthening existing ones, we keep raising the performance level of our office."

Many other parishes, state, federal and international agencies use the LBJTC. While here they spend money with local businesses.



Camera Network

Our surveillance camera network keeps expanding, playing a vital role in maintaining safety and convicting those who commit crimes.

"With nearly 550 cameras across the parish, we are literally keeping an eye on things 24/7," Sheriff Tregre said. "Cameras provide indisputable evidence that helps investigations and leads to extremely high conviction rates. Some cameras are visible while many others are hidden."



We assemble, program and install many cameras ourselves, allowing us to

install one on very short notice. "After a report of potential illegal activity, we can deploy a camera a few hours later and monitor the situation," Sheriff Tregre said. "Dispatchers can give officers descriptions of suspects and vehicles."

Fighting Illegal Drugs

The SJSO narcotics division confiscated some 95 kilograms of cocaine with a street value of about \$2.5 million from a LaPlace home in March. Three men were arrested, and 45 grams of fentanyl pills and eight illegal firearms were seized.

"Drug use ruins lives and fentanyl ends them," Sheriff Tregre said. "Since 2015, Louisiana has experienced a nearly 300 percent increase in opioid-related deaths, the third highest in the nation," Sheriff Tregre said. "Our deputies carry NARCAN and when administered it can save someone in an opioid overdose. But not always."


